*Amos*. Old Testament Library. Louisville, Ky.: Westminster John Knox, 2024. 90,000 words. Commissioned and in preparation.

The OTL series provides fresh and authoritative treatments of important aspects of Old Testament study. This commentary will offer a new translation of the Hebrew text and analyse the historical, social, and literary context of the book in light of recent research, as it seeks to convey the book's ongoing message for contemporary audiences.

*Israel's Crisis, Judah's Cradle: Identity in the Crucible of Babylonian Empire*. Society for the Study of the Old Testament Monograph Series. Cambridge: Cambridge University Press, 2021. 100,000 words. In preparation.

*Israel's Crisis* analyses the consequences for Israelite and Judahite identity of the destruction of Jerusalem by the Babylonians. It argues that the trauma of this event encouraged the reification of Israel as a social and theological identity amongst the deported Jerusalemite elites in Babylonia and the coalescence of a new, socially and economically comprehensive Judahite identity amongst those left behind. This divergence inspired a furious theological conflict between competing Israelite and Judahite identities, yet led ultimately to their unification as a single people, united around the worship of YHWH. The work is inspired by studies of forced migration, especially its impact on refugee communities' relationships with the homeland and narratives about the past, and by postcolonial analyses of imperial domination and its effect on native identities, including the amalgamation of disparate socio-economic classes and the invocation of unifying traditions in the face of colonial power.

*Isaiah: Prophecies of Judgment and Hope*. SOTS Old Testament Guides (New Series). London: Bloomsbury, 2020. 45,000 words. Commissioned and in preparation.

An introductory study guide addressing historical context, literary formation, and major theological themes; the historical and literary figure(s) of the prophet; and methods of current study.

*Translating Empire: Tell Fekheriyeh, Deuteronomy, and the Assyrian Treaty Tradition*. With J. Hutton. *Forschungen zum Alten Testament* 135. Tübingen: Mohr Siebeck, 2019. 342 pp. In press.

This volume offers a data-driven approach to translation practices in the Iron Age, building on and reinforcing conclusions drawn in *Israel and the Assyrians* about Deuteronomy and the Akkadian treaty tradition. *Translating Empire* employs “optimal translation” theory to analyze the Akkadian-Aramaic bilingual inscription from Tell Fekheriyeh, arguing that it exhibits an isomorphic style of translation and only occasional use of dynamic replacement sets. It applies these findings to other proposed instances of Iron Age translation from Akkadian to dialects of Northwest Semitic, including the relationship between Deuteronomy and the Succession Treaty of Esarhaddon and the relationship between the treaty of Aššur-nerari V with Mati’ilu and the Sefire treaties. It argues that the lexical and syntactic changes in these cases diverge so significantly from the model established by Tell Fekheriyeh as to exclude the possibility that they constitute translational relationships.

*An Introduction to the Study of Jeremiah*. T & T Clark Approaches to Biblical Studies. London: Bloomsbury, 2017. 208 pp. [pbk. 2017] [[sample chapter](#)]

This *Introduction* provides a concise entry point to Jeremiah, introducing the diverse approaches currently taken to the book, including theological interpretation, canonical criticism, postcolonial theory, feminist criticism, and trauma studies. It has been described as a ‘sure guide through tangled hermeneutical thickets’ (Sharp) and ‘an impressive balance of comprehensive discussion regarding critical issues in the study of the text and a detailed consideration of key passages’ (Leuchter).

*The Making of Israel: Cultural Diversity in the Southern Levant and the Formation of Ethnic Identity in Deuteronomy*. *Supplements to Vetus Testamentum* 162. Leiden: Brill, 2014. 279 pp. [pbk. 2016]

Integrating anthropology, archaeology, and biblical studies, *The Making of Israel* argues that Israelite identity was transformed by the social and political changes of the seventh century BCE. It analyses archaeological data from Egypt to Mesopotamia, then draws on anthropological theories of ethnic identity (Fredrik Barth et al.) to argue for an ethnic response to the economic, political, and cultural changes revealed by this material. An extended analysis of Deuteronomy constitutes the test case, and identifies a number of its ethical concerns, including its centralization agenda and its exclusive monotheism, as responses to these challenges to Israelite identity. It has been deemed ‘deeply instructive and amazingly engaging’ (West, *ZR*), a ‘sehr lesens- und bedenkenswerte Studie’ (Becker, *ZAW*) that undertakes a ‘serious confrontation’ with archaeological evidence and ‘enters into dialogue with contributions of the social sciences...to provide a theory much needed for a more profound analysis’ (Markl, *Biblica*).

*Israel and the Assyrians: Deuteronomy, the Succession Treaty of Esarhaddon, and the Nature of Subversion*. *Ancient Near East Monographs* 8. Atlanta, Ga.: Society of Biblical Literature, 2014. 216 pp. [pbk. 2014] [[open-access](#)]

*Israel and the Assyrians* examines Deuteronomy’s interest in the Israelites’ exclusive loyalty to YHWH and challenges the widely accepted theory that Deuteronomy is a subversive literary reception of the Assyrian Succession Treaty of Esarhaddon, as well as rejecting the possibility that Deuteronomy is a subversive appropriation of Assyrian concepts of political loyalty more generally. It stakes a claim in one of the most contentious areas of the discipline, undermining a major touchstone for the pre-exilic dating of Deuteronomy and problematizing the Israelites’ relationship with the Assyrian empire more widely. In reviews it been reckoned ‘conclusive’ (Kilchör, *JSS*), ‘a very compelling argument...demolishing long-held assumptions’ regarding the interpretation of Deuteronomy, with an argument that is ‘judicious, refreshingly disputatious, and convincing...Its value is immense’ (Coote, *RBL*).

*War and Ethics in the Ancient Near East: Military Violence in Light of Cosmology and History*. Beihefte zur Zeitschrift für die alttestamentliche Wissenschaft 407. Berlin: De Gruyter, 2009. 245 pp. [pbk. 2016]

Drawing on sociological theories of knowledge, *War and Ethics* argued that military violence in ancient Israel and Assyria was motivated by theologies of creation. Human kings' violent destruction of enemies was a moral imperative, demanded in imitation of their divine counterparts, who had defeated chaos in order to create an orderly universe. As the first monograph to locate biblical warfare in its ancient Near Eastern context, it took the field beyond accusations of gratuitous Assyrian cruelty and vague language of biblical 'holy war', identifying the key paradigm of ancient military violence and enabling a nuanced understanding of the conduct and rationale of ancient warfare. Reviewers described it as 'methodologically astute' (Tiemeyer, *SEA*), its thesis 'not only helpful but well proven' (Mayfield, *RBL*); a 'thoroughly researched' analysis that 'moves beyond theological, often ahistorical, orientations' and 'succeeds in resisting simplistic political or economic explanations for warfare...situating Israel's and Judah's war ethics within their ideological and social world' (Kelle, *CBQ*).
