I examined how society's discrimination of a historically disadvantaged group of Latinos (Puerto Ricans) was ameliorated and overcome by faith via the social support of the church and the ideology of the Gospel. I examined via ethnographic work how the church operate in liberating the oppressed and developed a model to understand how to replicate this liberation via mission in the inner city and anywhere oppressed people encounter the Gospel and form a supportive community of faith. I studied at Harvard University School of Education Department of Human Development and Psychology with a concentration in Cultural Psychology the dissertation (at HUGSE we were able to write a project or a dissertation I selected the academic option—a dissertation) entitled: "Religion, Education, and Success: In the Leominster Puerto Rican Seventh-day Adventist Church Community". Human development and cultural psychology are perfect disciplines for a Professor of Intercultural Studies with a focus on mission with a theorist/practitioner framework because they serve as theoretical vehicles to undertake a reading of the Bible for the two areas of theology from a practical theology perspective that facilitates the Gospel's work among the unreached from American cities to remote areas of the world.
- MA in Hebrew Scriptures and archaeology from Andrews University complemented with the year of Fellowship at the Semitic Museum at Harvard University qualify me to read the Hebrew Scriptures in the original language as a source of truth for understanding Christian Mission and Leadership.
